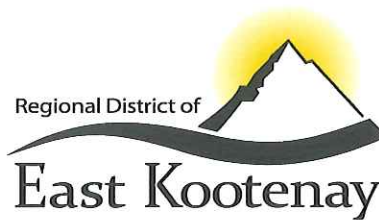

The Regional District of East Kootenay (RDEK) is initiating a review and update of its Solid Waste Management Plan (the Plan). The review and update will impact the entire Regional District including First Nations and member municipalities and we want to make sure that you are included in the process.

The updated Solid Waste Management Plan will provide options for solid waste management in the RDEK for the next 10 years.

We will keep you informed through the process via formal communications on plan updates and developments. We intend to contact you directly regarding issues that may impact your organization. Please contact me if you have any specific comments or concerns that you feel we should be aware of related to solid waste management.

The review process includes regular meetings of a Review Advisory Committee made up of members of the public and other stakeholders. This committee will help steer the Plan update and provide valuable input and perspective from all regions within the RDEK. We envision meetings to occur monthly from October 2018 through May 2019. We are starting to form this advisory committee and aim to include interested stakeholders including members of the public, industry experts, member municipalities, RDEK Board Directors and First Nations.

If you are interested in playing a larger role in this process, we welcome a member of your organization to join our Review Advisory Committee. Please contact me promptly if you are interested in joining the RAC committee. Otherwise, we will continue to update you on the Plan update as it progresses.

We want to make sure all stakeholders in the RDEK are able to provide input in the review and update process.
